

MARKET OUTLOOK FOR TODAY...

Market is likely to open on a positive note taking cues from firm global markets. US markets reversed heavy losses, overcoming poor Wall Street results and fresh evidence of a sclerotic housing recovery to finish the day higher. Asian stocks markets opened on an upbeat note as the overnight positive close on Wall Street and bargain hunting lifted stock prices in early trading. Meanwhile, reports about good monsoon rains in key grain-growing states, earnings expectations and continued FII buying may also keep the overall mood positive.

According to data released by the NSE, in the last session, **FII**s were net sellers of index futures to the tune of Rs 77.31 crore, while they bought index options worth Rs 44.42 crore. They were net buyers of stock futures to the tune of Rs 121.67 crore and sold stock options worth Rs 12.89 crore.
