

MARKET OUTLOOK FOR TODAY...

Market may open on a flat note mirroring mixed global cues. Wall Street stocks ended mixed yesterday, with the Dow Jones Industrial Average inching higher for a fourth straight session of gains built on solid company earnings. Asian stocks traded mostly higher with Japan leading the gains as the overnight mixed close on Wall Street and bargain hunting lifted stock prices in early trading. Meanwhile, strong year-over-year growth reported by heavyweight Reliance Industries, and the ongoing wave of monsoon rains across the country may keep market sentiment positive.

According to data released by the NSE, in the last session, **FII**s were net buyers of index futures to the tune of Rs 247.99 crore, while they bought index options worth Rs 1281.16 crore. They were net buyers of stock futures to the tune of Rs 36.74 crore and sold stock options worth Rs 58.10 crore.
