

## MARKET OUTLOOK FOR TODAY...

Key benchmark indices are likely to open lower with concerns about the pace of economic recovery weighing on sentiment. Wall Street markets ended an erratic day with a modest loss as investors tried to reconcile another batch of conflicting economic signals. Asian stocks lost ground after US markets fell amid uncertainty about current economic conditions. However, disappointing earnings from ONGC and Hero Honda Motors may keep the underlying movement negative.

According to data released by the NSE, in the last session, **FII**s were net buyers of index futures to the tune of Rs 505.61 crore, while they bought index options worth Rs 2285.47 crore. They were net sellers of stock futures to the tune of Rs 671.12 crore and sold stock options worth Rs 111.13 crore.
