In case of any change in these CMBP ID's, The Trading Member / broker is authorized to transfer the securities to the new account numbers with prior intimation to me / us regarding such change and to do all such acts, deeds things as may be necessary and expedient for or incidental to ensure that delivery of securities arising out of transaction undertaken by me / us under the agreement are duly and properly completed.
